

Assumption of Risk and Waiver of Liability Relating to Coronavirus/COVID-19

Zehra's Daycare, 11522 Culver Park Drive, Culver City CA 90230

Zehra's Daycare is a small community and we must all work together to ensure the safety of each child and each other during the Covid-19 Pandemic.

I _____ (parent's name) understand the following requirements to maintain a safe environment for all children and families at Zehra's Daycare:

1. All eligible members of each child's household must show proof of vaccination against Covid-19
2. All employees and household members of Zehra's Daycare are vaccinated, including booster shots when available, and will show proof upon request
3. I will not bring my child to daycare if they have a fever or show any signs of COVID-19
4. I will notify the daycare immediately if my child has a fever or shows any signs of COVID-19
5. If my child contracts COVID-19, I understand that they may not return to daycare for 14 days and I must submit a negative COVID-19 test result from a health care provider
6. If a member of my child's household, or someone they have been in contact with, contracts COVID-19, I understand that my child may not return to daycare for 14 days and that I must submit a negative COVID-19 test result from a health care provider
7. If my child begins to show symptoms while at Zehra's Daycare, I understand they will be kept isolated as best as possible from other children, and I must pick them up immediately
8. I will do my best to follow the safety precautions set in place by Los Angeles County and the Center for Disease Control
9. The following procedures must be followed each day:
 - a. Parents/guardians drop off/pick up children at side gate and do not enter daycare
 - b. Parents/guardians must wear a mask and only one person should drop off/pick up
 - c. Complete a daily symptom check at home and do not come to daycare if sick
 - d. Children will have a daily temperature check at drop-off

Regardless of any steps taken by Zehra's Daycare to reduce the risks associated with the COVID-19 pandemic, I am fully aware that there are a number of risks associated with my child's care at Zehra's Daycare during the COVID-19 pandemic, including without limitation, being exposed to and contracting COVID-19.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 by attending Zehra's Daycare and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 at Zehra's Daycare may result from the actions, omissions, or negligence of myself and others.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and

death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)'s attendance at Zehra's Daycare. On my behalf, and on behalf of my child(ren), I hereby release, covenant not to sue, discharge, and hold harmless Zehra's Daycare and its employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto.
